Stage 1 Submission

Submission can be made by:

1 The individual concerned, their families or legal representatives; or

>

2 Civil society organisations (upon consent of the alleged victims, their families, or their representatives)

Content of submission (max. 20 pages including annexes):*

- Victim's identity
 Information on the circumstances of the arrest or detention

Stage 2 Opportunity for Government to Respond

Submission could be sent by:



allegation to the Government concerned.





Government may reply within 60 days.

If no reply is submitted within the time limit, the Working Group may render an opinion in absence of the reply.

Stage 3 Working Group Opinion

Following measures will be adopted in private session:

Findings	Action
If the arbitrary nature is established	The WGAD will render an opinion and make recommendations to the Government
If the person has been released	The case is filed , but the WGAD reserves the right to render an opinion on a case-by-case basis
If the case is not considered as the arbitrary deprivation of liberty	The WGAD will render an opinion
If further information is required	The case is pending until such information is received
If sufficient information on the case is considered unable to be obtained	The case may be filed provisionally or definitively

The opinion (and the recommendations) is sent to the Government 48 hours after this notification. The opinion is also conveyed to the source for information, and are published online.



Follow-Up

Governments, petitioner and other parties (including civil society organisations) should inform the WGAD of the follow-up action taken on the recommendations made by the WGAD in its opinion



Review of Opinion

The WGAD may reconsider its opinion, at its own discretion or at the request of the Government concerned or the petitioner, if it becomes aware of **new** facts that would led the WGAD to a
